1.0 INTRODUCTION

1.1 This report is a recollection of events emanating from the tour of Rotuma by the Interim Prime Minister and his delegation of Cabinet Ministers together with other Government advisors for the celebration of the Rotuma Day, the convening of the Rotuma Island Development Committee meeting and other activities.

2.0 BACKGROUND

- 2.1 The visit to Rotuma by the Interim Prime Minister came about as a result of an invitation by the Chairman of the Rotuma Island Council.
- 2.2 The original intention was for Cabinet to be convened in Rotuma however due to financial constraints Government thought fit to send a delegation consisting of Cabinet Ministers to be headed by the Interim Prime Minister to attend the Rotuma Day Celebrations followed by a meeting with the Rotuma Island Development Committee, a meeting with the seven Chiefs followed by "Talanoa" sessions at the 7 districts headed by each Minister.
- 2.3 Overall, the tour was hailed as a success, however, this can only be measured once all development issues raised during the tour are successfully implemented which, in turn will enhance the island capacity both in terms of boosting the social and economic well being of the island population.

3.0 DAY ONE – TRADITIONAL WELCOME CEREMONY

(MONDAY 12/5/08) - "Mamasa"

3.1 The schedule on day one involves the Interim Prime Minister, the Minister for Works and Transport, the Minister for Health, Social Welfare, Women and Housing, the Minister for Industries, Trade, Industrial Relations and Tourism with selected Senior Civil Servants were accorded with a "Mamasa" ceremony conducted by the Chiefs of the District of Malha'a.





3.2 A grand site to witness which at its culmination the guest were entertained with cultural dances as it can only be confirmed that Rotuma and its population are still very much part of their culture and the important attach.





still very much part of their culture and the important attachment to their land as the belief goes; 'land has eyes and ears' hence bear its significance to their cultural dances.



- 3.3 The 2nd Meeting of the Rotuma Island Development committee Meeting was convened at 2.00pm and opened by the Interim Prime Minister.
- 3.4 The meeting discussed <u>key issues</u> raised in last year's meeting involving 9 Key Issues have been dealt-with the exception of two that have been implemented in part and marked as <u>Annexure 'A'</u> (Resolution Matrix of the 9 key issues resolved last year)



3.5 The meeting also resolved that Key Issues raised as reproduced here under be considered by government.

4.0 <u>DAY ONE – 2008 ROTUMA ISLAND DEVELOPMENT</u> <u>COMMITTEE MEETING (SUMMARY OF KEY ISSUES)</u>

4.1 **Infrastructures:**

(i) The RIDC endorsed that the Ministry of Works be invited to set aside \$250,000 an effort to upgrade the road around the island and be dedicated as National Roads. In an effort to maintain the roads on the island the Minister for Works had also agreed to the purchase of 1 loader, 1 grader and 2 trucks to be factored into the budget proposal for 2009 in an effort to establish a fully fledged deport in Rotuma. The

council was invited to consider an alternative site for the relocation of a new depot.

4.2 Airport Upgrading:

(i) The meeting was briefed that AFL is in the process of finalizing the scope and the design of works that is required to upgrade the Airports to Code [C] and will open up the airport for International flights.



(ii) The runaway strip needs to be widened by another 6 meters and to correct the runaway surface, the upgrade works includes sealing and to put in place boarder control infrastructures, navigational aids and other requirements to comply with ICAO safety requirements.



- (iii)Cost of the upgrading to be accessed when the design is finalized by AFL and upgrading works to be undertaken by the Ministry of Works. The upgrading and sealing programmes when completed, CAAFI will then be invited to comply.
- (iv) The cost of upgrading works of Phase II is estimated at \$1.7 million. The meeting endorsed that Phase II be implemented.

4.3 **Fishing Industry:**

- (i) The meeting heard that the Rotuma Council had held discussions with Fisheries and identified options open to them on the utilization of the two (2) Fishing Licenses are being considered as follows:
 - i] To utilize the licenses this requires major financial outlay, expertise inputs and other resources;
 - ii] To lease the license to an operator, or
 - iii] To consider partnership with an Operator.
- (ii) The meeting endorsed that the matter be given more thought to speed up the process and agree on the best options that will derive maximum return to the Council or its business arm.

4.4 Reliable Power Supply:

(i) The meeting was briefed that while SOPAC is working on a long term solution of providing renewable energy supply to the whole island, the other option is to produce two bigger generators and use renewable /bio-fuel to enhance cost effective measures to be run for 24 hours basis covering the whole island. This is a long term plan, hence the meeting also agreed to endorse the proposal.

4.5 **Pending Self Help Projects:**

(i) The Commissioner Eastern Division had confirmed that only 5 clients were left to be assisted through the Rural Housing Assistance Scheme. The Ministry of Finance upon releasing of funds in the second quarter will enable us to fund the 5 requests.

4.6 Rotuma Land Act/Rotuma Act:

(i) The interim Prime Minister has agreed for a Review of both Acts to be carried out simultaneously. By virtue of being Minister responsible for the affairs of Rotuma will then appoint a review team after a TOR has been drawn up and endorsed.

4.7 Fire Arms License:

- (i) The meeting endorsed that the Commissioner Eastern to raise, with the Commissioner of Police the following issues:
 - i] Extend the age limits of license holder from 60-70 years;
 - ii] The DO Rotuma and / or the Rotuma Station officer to store and retail firearms.

4.8 Strategic Development Plan:

(i) The meeting endorsed that the Commissioner Eastern /Office of the Prime Minister to assist the Council in securing funds and also enhance appointment of a team to assist the Council of Rotuma Island in developing a Strategic Development Plan. The time frame given is 3 months and to be considered for extension if need be.

4.9 **Proposed Rotuma Building Complex:**

(i) The Development Committee endorsed that the Office of the Prime Minister to consult with the Public Service Commission and Ministry of Finance on the viability of a Rotuma Building complex to be located in Rotuma and rented by Government.

4.10 Trade with Tuvalu/HTFA:

(i) The meeting endorsed at the end of the presentation by Director Quarantine that the Office of the Prime Minister to provide funding for the HTFA package which includes the HTFA plant, laboratory, shed to house the plant; inspection shed, a shed at the wharf, a quarters for a staff and a vehicle at the total cost of approximately \$0.6m.

4.11 Hospital:

(i) The meeting endorsed the sentiments expressed by the Ministry for Health that the Ministry has decided to build a new hospital at the cost of \$800,000 as against repairing the current one being estimated to cost \$600,000. What is left now is for Cabinet to endorse it including reprioritization of funds. Once

endorsed, the project will start either this year or early next year.

4.12 **Acquisition of Birth Certificates:**

(i) The meeting endorsed that the office of the Prime Minister to pursue with the Permanent Secretary for Justice on the possibility of linking up the Registrar General's system with the District Officers, to enable the speedy issuance of Birth Certificates, Marriage Certificates and Death Certificates. This will also required policy changes to speed up resolving this problem.

4.13 Water Supply:

(i) The meeting endorsed the PM's assurance to enhance speedy resolution in an effort to secure funds for the provision of \$40,000 to purchase new pump and a generator to enable the Sumi borehole to continue operations and supply water. The existing arrangement requires only two (2) other boreholes at Motusa & Lapjea working but insufficient to meet the demand.

4.14 **Port of Calls:**

- (i) The Committee endorsed and the following were to be further pursued:-
 - Agents for Ports Authority of Fiji to be located on the island;
 - Port security for the ports areas;
 - Responsibility for upgrading of ports infrastructures
- (ii) At the conclusion of the meeting of the Task Force on Tuesday 13/5/08. The following were agreed:-
 - Agents for Ports Rotuma Island Council;
 - Security for Ports to be the responsibility of the Fiji Police on the Island:
 - Responsibility for upgrading of Ports Facilities Construction of shed and repair of existing shed one security gate, toilet facilities and lighting. Ministry of Works and Commissioner Eastern Division's Office.



5.0 DAY TWO – ROTUMA DAY CELEBRATIONS:

- 5.1 **(TUESDAY 13/05/08)**
- 5.2 The celebration began at the Cession Site followed by a march led by the Fiji Military Forces Band and school children from the Session Site to Ahau Government Station.
- 5.3 The celebration was then declared open by the Interim
 Prime Minister followed by cultural dances and other
 competition to fill the days programme (refer to
 Appendix 1 for Extract of Speech).





5.5 It is to be noted that in his closing address, the Minister for Works had also made a commitment that \$5,000 donations will be given by the Interim Prime Minister for Rotuma High School hence the Management were also invited to submit proposal worth \$5,000 to the Prime Minister's Office for the release of funds.

6.0 <u>DAY THREE - TALANOA SESSIONS AT THE SEVEN</u> <u>DISTRICTS</u>

(WEDNESDAY - 14/05/08)

6.1 The teams were divided into three with the following areas being covered and talanoa sessions were held at each site.

6.2 Discussion held at each site have been recorded and marked as (Appendix 2)

- 6.3 The Interim Prime Minister met with the Chiefs of the seven districts in Rotuma at Oinafa to discuss the review of the Rotuma Island structure so that it addresses the current traditional problems facing the island at the moment; this should be part of the review of the Rotuma act and the Rotuma Land Act.
- 6.4 A meeting of the Development Taskforce was held at Oinafa Port to discuss on upgrading the Port Areas and other facilities including security requirements.
- 6.5 The meeting agreed on the following issues be followed up hence the following updates on Port of Issues and Summary of Costs for each activity.

7.0 OBSERVATION

- 7.1 The tour has been hailed by the Prime Minister as a success. The only sour point was the large number of Civil Servants accompanying such tour MUST be reduced to a workable size to at least 50 and must consists of Permanent Secretaries, Deputy Secretary and Directors to hear at first hand the grievances of our rural communities and find ways to resolve issues there on the spot.
- 7.2 The Interim PM further noted that all key issues raised must be resolved within 3 months and Cabinet is informed forthwith of actions taken.
- 7.3 Some urgent issues that need government immediate attentions are as follows:
 - [i] Generator for the Water Supply to be considered for reprioritization and purchased immediately to resolve the water problem on the island.
 - [ii] The establishment of a HTFA treatment plant is implemented before the year ends hence the need to release funds to the Director Quarantine for its implementation.
 - [iii] The upgrading works at Oinafa Jetty is implemented soon to meet minimum requirements. This includes the repair and construction of the existing Shed and Bonding Area. The provision of lights at the wharf and improvement to the Water supply system at the wharf;

- [iv] The upgrading of roads around the island to national standard be funded from within and implemented;
- [v] The widening of the airstrip and sealing to meet ICAO & MRD standard to be funded and implemented;
- [vi] The construction of an Incinerator at the Airport;
- [vii] The issuance of Birth, Death & marriage certificate at the DO's Office Rotuma;
- [viii] The storage of Arms & Ammunition at the Police Station, Rotuma.
